Update on South Sudan

Since last I wrote momentous events have taken place in Sudan.

Pride of place goes to July 9th 'Independence Day", when the world's newest nation was born, "The Republic of South Sudan". (Now officially named the poorest country in the world].

In the midst of wide-spread violence, tribal clashes, random shootings, killings, revenge, retribution, bombings and threats of genocide the country stood still for one magic moment as the new South Sudan flag was raised in every corner of the country, and countless voices were raised in the singing of the new national anthem.

Here in Mapuordit the day began with a wonderful Mass. The Church was packed to overflowing. The main celebrant was Father Mark, the one and only Sudanese priest in our

Since July 9th South Sudan in many areas has slipped back into its familiar way of life and violence continues to create fear, and some IDP's have become displaced a second time.

We are still in the process of sharing your wonderful contributions to the needy:

- (1) food which is still in very short supply in the markets,
- (2) Water one water pump has been installed. but at least two more are needed
- (3) Rebuilding of burnt-out homes -still in process but hampered by the wet season which is still with us,
- (4) A school to help rebuild, for the beginning of next year.

This is how we use "Mapuordit Emergency" funds. But we still have our normal projects to keep going -schools, hospitals, women, the poor, and incidental needs that pop up at any



Dear Members of the Overseas Aid Board,

We wish to thank you very much for the care and consideration you have given to our ministries in South Africa over many years.

As you know, our Diocese is the second poorest in the country, larger than Tasmania and very rural. Across this area our five communities are scattered and each one faces the daily reality of orphans, refugees, unemployed, disenchanted youth, sick and distressed people coming for help.

There has been a significant decline in funding over the last twelve months everywhere. It seems to be a world-wide issue with money markets volatile and investments shaky. Bakhita with St Brendan's supports 44 girls and lost a big investor when the Swiss Solon Foundation just dropped to assisting only 7 and saying that they will continue to decrease each year until they no longer help with food, fees, uniforms or personal needs.

The President's fund from America that supported the Anti-Retroviral Treatment (ART) and the nursing staff's wages is folding up and that has been a huge disappointment. The Catholic Relief Services is pulling out of the Home Based Care projects at the end of this month meaning that many carers are now out of pocket and receiving no stipend to feed their families.

We are forced to lay off bread-winners in an already fragile economy. They will need to be assisted in the Poverty Alleviation if no job is found quickly. 70% of youth are unemployed and it seems even more difficult for an older man, limited in skills, to get work. We have them knocking at our door several times a week.

Last night on the National News the Education Department was reporting on the infrastructure shortage in the schools. There are over 3000 with no electricity, 2,400 with no water, 1,100 with no toilets, 20,000 with no libraries and 21,000 with no laboratories.





Most of these schools are where the village orphans go and where the Ametur money to support them is needed. Of course, their own homes are like their local schools — no electricity, no water (it has to be bought from a truck that comes around or, if they are lucky, they get some from a nearby creek).


As you are needing to discern where to support, with what donations have come in, I believe you should know that our situation has worsened and the coal-face aspect of helping the poorest is in reality drying up and they are suffering greatly. It is bitterly cold and raining on and off ... strange for August here but that is how it is. I realize that you have only what is sent in to work from so ask only that you consider the number of works we are responsible for within South Africa. Again I thank you on behalf of the Australian Sisters here.
