MINUTES

The Minutes of the 2011 Annual General Meeting, held on April 24 2012, having been circulated to the members prior to the meeting, were tabled and taken as read. It was moved by Gloria Gallagher and seconded by Jim Evans that they be accepted as an accurate record of the meeting. All members agreed.

ANNUAL REPORT

The Annual Report was tabled and read by the Executive Officer Barbara Davis. Sr Pauline Compton and Sr Elaine Cochrane were encouraged to speak about the different Sisters in each area as their areas were mentioned, especially South Sudan where Sr Pauline has just visited. She commented in particular on the lack of infrastructure there.

The Executive Officer's Report made mention of the changes in procedure leading to being accepted as a full member of ACFID, to be validated in November at the ACFID Council. These included production of policies for:

- Child Protection
- Complaints Handling
- Governance
- Anti-Fraud, Bribery and Anti-Corruption
- Conflict of Interest
- Discrimination and Harassment
- Fundraising
- Occupational Health and Safety
- Privacy
- Developmental and Non-Developmental

It also mentioned changes to application and acquittal forms to comply with ACFID's Code of Conduct.

FINANCIAL REPORT

Mr Jim Evans, a Chartered Accountant and our Honorary Auditor, tabled the Financial Report.

He noted that income had decreased a little from the previous year. Jim thanked and congratulated Barbara on her clear bookkeeping. Mr O'Dea responded by voicing appreciation to both Barbara and to Jim for their authentication of the finances.

The motion was moved by Jim Evans and seconded by Michael O'Dea that the Financial Statements be signed as an accurate record of the position of the Overseas Aid Fund. The motion was accepted by all present.

Michael commented on the vicarious pleasure received from helping in some small way the needy in our world. He expressed gratitude that there were young sisters coming through in some areas of the world, especially Africa and the Pacific Islands. He said that they wouldn't be there if it weren't for the OLSH Sisters being there first.

Michael expressed appreciation again for the work over the years as treasurer of Bill Barry and Barbara was asked to contact his widow Joyce.



OTHER BUSINESS

- o Michael O'Dea expressed the need for the OLSH Overseas Aid Constitution to be updated as a matter of urgency.
- o Michael expressed disappointment at the lack of response from OLSH College Bentleigh to feature OLSH Overseas Aid more fully in their Alumnae magazine Flame.
- o Michael spoke of his attempt to organize a lunch for the largest of our donors, and their lack of interest in the idea, not wanting a fuss.
- o It was decided that the largest donors for the year would again be sent a copy of the Annual General Report, except the ones who had asked not to be sent one.
- o Sr Pauline thought that copies of KIT could be left in parishes. This led to a discussion of the difficulty of persuading parish priests to agree to one of the Sisters speaking at their masses. Jim Evans mentioned that his Parish Priest Fr Kelvin at Miranda is open to the idea of having an OLSH Mission Sister speak at his masses. Sr Lorraine Cleary was identified as being available and suitable. Gloria mentioned the importance of highlighting how people in many countries live; eg children depending on being fed at school, and their hunger during holiday periods.
- o It was noted how much demand there is on people to donate to many different charities, but that an event is an effective way of raising a lot of money. There was a discussion about the need to find younger people to commit to fundraising for the Fund as current members are getting older. Jo mentioned that people in their thirties and forties often have different priorities. Both Michael and Pauline committed to asking family members if they would be interested in organizing an event.
- o Michael has expressed a goal for 2013—to break the \$800 000 barrier in fundraising.

Michael O'Dea thanked everyone for their attendance and closed the meeting at 7pm. Members were invited to refreshments which followed.



Statement of the Goals and Objectives of Daughters of Our Lady of the Sacred Heart Overseas Aid Incorporated Fund

The objectives of Our Lady of the Sacred Heart Overseas Aid Incorporated Fund are:-

- a) to provide for the relief of persons in countries which are, for the time being, certified by the Minister for Foreign Affairs to be Certified Countries ("Certified Countries") pursuant to the provisions of the Income Tax Assessment Act, 1997, and, without limiting the foregoing, to include relief of persons in Angola, Burkina Faso, Kiribati, Papua New Guinea, Philippines, South Africa and Sudan.
- b) Pursuant to objective (a) and, without limiting its generality, to provide aid in the following manner:
 - i) by the relief of persons in necessitous circumstances in Certified Countries;
 - ii) to provide education for persons in necessitous circumstances in Certified Countries;
 - iii) to provide accommodation for persons in necessitous circumstances in Certified Countries;
 - iv) to provide food and sustenance for persons in necessitous circumstances in Certified Countries;
 - v) to establish and/or construct schools and/or teaching institutions for the purposes of educating persons in necessitous circumstances in Certified Countries;
- c) To assist in the funding of relief and development work carried on by the Religious Sisters known as the Daughters of Our Lady of the Sacred Heart in Angola, Burkina Faso, Kiribati, Papua New Guinea, Philippines, South Africa and Sudan.

The main thrust of the work of the Fund continues to be in education, health care, and social and community development. From time to time we are asked to respond to other needs but these are temporary and directed to providing only urgent, short-term aid. Our support for education, health care and development are normally on a continuing, long-term basis.

Since the establishment of the Fund it has been our consistent objective to encourage and promote self-help programs which aim to improve people's general standard of living and help establish for the local people a life-style more worthy of their human dignity. We continue to espouse the following goals:

- provision of a basic standard of living
- care of children and the elderly
- empowerment of women and other vulnerable groups
- elimination of hunger through sustainable agricultural development
- encouragement of individual and communal self-help projects

In this way we aim to create a greater solidarity with and empowerment of the local people by the sharing of our resources for their betterment and ultimate self-sufficiency.

Angola

The DOLSH Mission at Cazombo has accommodation for up to twenty-five girls. They study literacy and numeracy for part of the day and vocational skills such as learning to bake, sew etc for the rest of the day. They sell the produce they grow in the garden and make—such as bread and jams. This helps to subsidize the cost of their education.

Burkina Faso

During 2013 OLSH Overseas Aid funded AUD 9970 towards the building of the future Zagtoui Primary School. Zagtoui is a very poor area of Ouagadougou, the capital of Burkina Faso.

Background: Parents of children enrolled at the Jules Chevalier Nursery School requested the building of a primary school as local schools are over-crowded. The school will cater for about 300 students. Phase One of the building will be 3 classrooms, an office, storage room and toilet facilities. Phase Two will be a second floor with 3 more classrooms. As of February 2014, they are waiting on the results of soil analysis to enable approval for construction to begin.

Fiji

Two projects were completed on Rabi Island in 2013:

- Youth Piggery - This project involved building a piggery on Rabi Island which the youth of the area will operate as an income-producing operation.
- Buakonikai Community Hall - Buakonikai is located twenty-two kilometres from the main centre of Nuku on Rabi Island. This project involved the construction of a community hall for various village related activities.

Education

- **Tutorial Program in Matantubig:** This program is intended to help primary school children who are having difficulty with reading comprehension, English, mathematics and science. In 2013 tutorial classes were given to children from Grades 1 to 6. The tutorials are held in the afternoon after school for an hour or two a week. Music and Art workshops are also provided.
- Educational assistance for needy children.
- Capital Education Project—a tertiary support program for poor students in Matantubig.

- **Nutrition Programs:** Matantubig, Surigao

Community

- **Pig-raising Programs**—An ongoing project.
- Emergency Relief for people affected by Cyclone Hiann.

South Africa

Ametur Project— Sr Christine Martin

In 2013 there was a focus on three major areas:

- Education - Provision of uniforms, and support for excursions, transport and stationery for orphaned students
- Skills Centre:
 - ◊ The first six women to graduate are setting up their own dressmaking businesses.
 - ◊ Garments are being made for sale at the markets
 - ◊ Overseas Aid paid transport costs for each trainee to come to the Skills Centre.
- Community
 - ◊ Roof repairs, fencing wire, kitchen pots for outdoor cooking. Tertiary students in hostel accommodation have needed two ring stoves, plastic bathing tubs, irons etc so they can be self-sufficient.
 - ◊ Two new Lenovo Think Pads and software for administrative tasks in the whole area.

Holy Family Care Centre—Sr Sally Duigan

- A special project was set up to support a number of children presently residing at Holy Family who have special needs and require the care of a specialist educator, and a registered nurse to supervise the Anti-Retroviral Treatment program for HIV positive children.

Bakhita Village—Sr Merrilyn Lee

- Monthly stipends for carers
- Cleaning materials and household items
- Transport for students—the primary school is several kilometres away from Bakhita Village.
- Educational support—uniforms, fees, etc

Ave Maria Pastoral Centre—Srs Jane Dalton and Claudette Hiosan

In 2013 the Ave Maria Pastoral Centre in Mooketsi provided support to tertiary students with potential leadership qualities to attend courses inside and outside the Centre. Refugees have been empowered through subsidies for transport costs, provisions of tools and improved family living conditions.

OLSH Clinic at Nzhelele—Sr Mairead Kelleher

The Sacred Heart Clinic in Nzhelele provides regular treatment for more than 70 patients, as well as supporting daily patients and children at the drop-in centre:

- Buildings needed painting, roofing repairs, new guttering and downpipes, aluminum window frames, some new glass and screens.
- Electrical wiring, plumbing, thatched roofing and some fences were repaired.
- Maintenance of vegetable gardens by 3 Zimbabwean refugees.
- Special thanks go to Ron Knolder (Sr Marilyn Knolder's brother) who supervised this project while volunteering in South Africa. His expertise and enthusiasm were invaluable.

South Sudan

Education—Sr Philippa Murphy, Sr Mary Batchelor, Sr Rita Grunke

Sr Philippa Murphy has gradually been handing over the leadership of the Comboni Secondary School to local staff during 2013, and left the country at the end of the year with the necessary resources to provide an excellent education. Sr Mary Batchelor is still Principal of the primary school and Sr Rita Grunke is very involved with satellite schools. During 2013, the Overseas Aid Fund contributed to a number of satellite schools by providing funds to construct permanent metal roofing.

Health—Sr Mary Batchelor, Pauline Carr

- Medicines for Mary Immaculate Hospital (112 beds)—Twice yearly supply of medicines from Nairobi helped cover the needs of 4166 inpatients and 29248 outpatients in 2013 (Figures from Mary Immaculate Hospital 2013 Annual Report).
- Medical Supplies for Mary Immaculate Hospital— Various supplies, including a new latrine block and wheelchairs.
- Professional Training of Staff—Academic and Living Allowances for students of the Certified Nursing Course offered at Rumbek Nurse Training School.

Community

- Agany Women's Development— Fruit trees and vegetables have been planted.
- Grinding Mill—Profits are to be shared with a nearby satellite school.
- Funding Towards a New Vehicle for Outreach Services—The Landcruiser purchased in 2007 used for outreach programs and school visitations needs to be replaced.
- Support for Poor Women and Children—Basic housing with fencing for poor, disabled people and lepers. Food for Work Program.
- Volunteers' Compound—Repairs to ensure safe, secure accommodation as well as provision of basic necessities for the expat staff.
- Skills Training: Training and employment of various local men and women.
- Clean Water Projects— Two more water pumps have been installed to provide clean water in Mapuordit.



- Sacred Heart Parish, Mt Druitt— Fr Charles Ashton continues to organise the Parish Lenten contributions to be allocated to South Sudan, approximately \$12 146 in 2013.
- Gift Certificates—\$6107 was raised in 2013 from gift certificates issued to nine different donors.
- Romero Company—Yearly Dramatic Production of Les Miserables by Sr Janet Mead raised \$5000 in November.
- In Memoriam donations for Sr Mary Fyfe amounted to \$4395.
